# **Description of necessary first aid measures**

Eve contact : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower

eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10

minutes. Get medical attention. If necessary, call a poison center or physician.

## Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. ### Methods and materials for containment and cleaning up

Small spill

## Precautions for safe handling

Protective measures
